3. The second is follow up from last week. Last week abstentions were brought up I thought I would look into it and clarify the rules and guidelines for abstentions. The

first thing that I found was that based on our bylaws, constitution, Operating manuals, and Roberts rules, the only time you are required to abstain you vote is in finance voting on funding for an organization you are apart of. Besides that you are currently never required to abstain. However it is generally frowned upon to vote in cases where you have personal stakes such as recognition of an org that you are apart of or giving someone who is in an org you share an influential position. Please remember if you ever have a question of whether or not you should abstain, please feel free to ask SGAs legal counsel or a good rule of thumb is if you feel unsure abstain and after the meeting feel free to check with Cole or me.

4. Finally I wanted to talk a bit about how constitutional amendments work since we have a couple coming up today. For a constitutional amendment to pass it needs to receive a $2/3$ vote in two back-to-back senate meetings. So that means that if the amendments receive that $2/3$ vote today they aren't considered a passed amendment unless they receive the $2/3$ vote to pass again next week. In both week changes can be made to the amendment on the floor.

This just fixes it and turns it into what was more intended. For outside orgs of SGA.

a. My concern on this is I think it's in order to have this amendment done.

However, we need to be a little bit more specific because it says the person shouldn't participate in senatorial position means lateral. You know the people that will verify the documents was into that position. I think it should be the present if once you are coming out for the position you shouldn't be part of the electoral committee, whether it's senatorial position or any other position. So to avoid prejudice or kind of balances. So I'm such I'm suggesting that it should be once you're coming out for any position in SGA or from any other part you shouldn't be part of the electoral committee.

They are by definition on the SGA, which means they cannot review anyone who was also an SGA.. Are you trying? Are you saying, suggesting we should change how the Board of Elections gets chosen away from senators?

a. Yeah, so I'm suggesting that. If the present is going to probably be executive position. The business should not be part of Electoral Committee. Today, there could be you can't be a judge. Even if you're not directly involved in decision of who should be approved or not, but you can somehow have a kind of influence. So my suggestion is if you are for instance you are a senator and

you are going for any other probably you should focus more on your election than being part of the Electoral Committee.

Let's say you were a senator your freshman year and later on you want to be an executive. Right now, the board could not review them. So even if they have stopped being a senator for you since they had previously shared an SGA position that the senators of the Board of Elections are on, they could not look at this candidate. So even if they had stopped being a Senator for you since they had at one point done it and they could be 100% focused on that executive position. They still couldn't be reviewed. This doesn't like focus or encourage one or the other. It's just if someone has been on SGA before, we are able to look at them, whereas as it stands now we are not able to look at them. We aren't able to review their application. As long as the Board of Elections has a majority of people from the SGA

- a. Good afternoon Speaker Hensley, Deputy Speaker English, and members of the SGA Senate. As a kid from a small town in Iowa, we were taught that your actions mean more than your words. Simply put, I am better at doing it than saying it. However, I will do my best here to "say" why I desire to be selected as the next Deputy Treasurer of the Student Government Association. Now a little more about me and what I believe can help you with your decision today. As a finance major, I have already developed many skills that could assist me in the role of Deputy Treasurer of the SGA. I have developed both Microsoft Access and Excel skills beyond the basic level, excellent note taking skills, and real-world experience already with my work consulting for Rockford promise. Further, I was involved in several organizations and clubs while in high school. All of these are reasons why I believe I would be a good fit for the role of deputy treasurer.
