2. Deputy Speaker English seconded
3. Senator Rosales states
 - a. This is the part of the opening ceremony for the Senate and yeah
4. Deputy Speaker English states
 - a. The changes from last week are the closing ceremony because that falls under adjournment ceremony, I will undo whatever is done. Opening ceremony for walking. If you want more specific you can do it there, but I strongly suggest to all senators today to vote on this bill one way or another. Because based on suggestion here and on other universities as well as staff. This is what we can make changes to it, but I don't think we should be tabling this over and over again. 2. Deputy Speaker English seconded
3. Sergeant-At-Arms Bereolos states
 - a. This is a resolution to add one more date to elections. It will be now Monday, Tuesday, and Wednesday. This will allow for people who are not on campus on either of those two days can vote in person. I'm not here on Mondays so I know it allows for more people to vote.
4. Speaker Hensley asks if there is any discussion or debate.

7. The resolution passes with a vote count of 10 yays, 3 nays, and 0 abstentions.

D. SR55036

1. Deputy Speaker English makes a motion to hear SR55036

3. Sergeant-At-Arms Bereolos states
 - a. This is a resolution to cement the amount of Senators position in Housing for students living on campus and it will just make it easier for the next Election

Commissioner for them to set the number of Senate seats to ten percent. This allows for more seats for housing.

4. Senator Rosales states

a. Do you now know how many seats are up for Housing?

5. Sergeant-At-Arms Bereolos states

a. For this upcoming election, there will be four seats for Housing. Two seats will be up for election in Spring election and two will be reserved for the fall for incoming freshmen.

E. SR55037

1. Deputy Speaker English makes a motion to hear SR55037

2. Sergeant-At-Arms Bereolos seconded

3. Sergeant-At-Arms Bereolos states

a. This is just a resolution to clarify where members of the candidate and the candidate themselves can be for this election. This is just making it so that they cannot be inside a building that contains a polling place or within one hundred feet of the polling place.

4. Speaker Hensley asks if there is any discussion or debate

5. Senator Rosales states

a. Where is exactly one hundred feet from the Student Center? I know in previous elections there were folks and markers who would stop people from campaigning in the area. How do we know where?

6. Deputy Speaker English states

a. It is the job of the Board of Elections to have people to staff these voting polling places. So they would have to have staff that would be in charge of making sure the rules are being enforced and it will be at the discretion of the Board of Elections.

7. Senator Guerrero states

- a. It is one hundred feet vertically and one hundred feet in every direction.
8. Deputy Speaker English states
- a. One of the biggest changes to this is setting it to the building so it is no longer vague. It will be a spherical radius and it will affect every place that is not the ground and that is what helps the staffing of it. It will allow them to not have to be on all floors and it allows staff to just be able to patrol around instead. This includes the body of the building and does not include any part of the building outside like the bridge that connects Swen Parson to the library.
9. Chairperson Anastopoulos states
- a. You want to staff the polling places at every station?
10. Sergeant-At-Arms Bereolos
- a. I want it so that it is the blatantly obvious people especially any social media posts will be marked against them.
11. Chairperson Anastopoulos states
- a. I honestly don't see a problem with being within the 100 feet radius outside and I see that the staff would be better utilized elsewhere instead of just walking around outside during elections.
12. Sergeant-At-Arms Bereolos states
- a. It just to stop candidates from pressuring people into voting. I believe it happened a lot last year's election but the Election Commissioner didn't do anything about it since there wasn't enough evidence. This is just further rule to allow us to punish more efficiently with sufficient evidence.
13. Chairperson Anastopoulos states
- a. How will the public advertisement of the elections happen if we cannot campaign near the HSC, where most students pass by while on campus?
14. Sergeant-At-Arms Bereolos states
- a. I am already talking with advertising and we are planning that. We will be making posters and advertisements for the meetings. These will be discussed further within the candidate meetings later on.
15. Speaker Hensley calls for a vote
16. The resolution passes with a vote count of 12 yays, 1 nay, and 0 abstentions.

F. SR55038

1. Sergeant-At-Arms Bereolos makes a motion to hear SR55038
2. Deputy Speaker English seconded
3. Deputy Speaker English states
 - a. All these orgs went through the process. Director of Organizational Development James Innis approved them and Organizational Oversight look through them. Some of them had minor changes and they were able to send corrections timely. They are all good.
4. Speaker Hensley asks if there is any discussion or debate
5. Senator Rosales states
 - a. I would like to hear the purpose of the Belegarth one.
6. Deputy Speaker English states
 - a. The purpose of our organization is to educate members in the disciplines of medieval combat, educate members in medieval history (including combat, lifestyle, art, clothing, and daily life), to provide guidance in self-discipline, sportsmanship, and how to be a team player. Our goals include practicing self-control, self-discipline, improving our fitness through physical exercise and growing into a close-knit community of trusted team players.
