1. Speaker Hensley calls for a motion to discuss agenda item A. SR55007: A resolution to confirm Director Appointments
2. Deputy Speaker English so moved.
3. Senator Rosales seconded.
4. Speaker Hensley introduces the resolution
5. Speaker Hensley states
 - a. The appointed director for this position is Arianna. She is not here. She was scheduled to come up two weeks ago. She pushed it back to today. It is your guys' choice how we proceed.
6. Speaker Hensley asks if there is any discussion or debate.
7. Deputy Speaker English is recognized.
8. Deputy Speaker English states
 - a. Has she made a statement of when she would be available?
9. Speaker Hensley states
 - a. Yes and it was for today
10. Senator Anastopoulos is recognized.
11. Senator Anastopoulos states
 - a. Has she made any sort of communication that she was going to be here today or not be here today?
12. Speaker Hensley states that there were no attempts of communication
13. Senator Rosales is recognized. and yields his question
14. Senator Anastopoulos is recognized.
15. Senator Anastopoulos moves to kill the main motion
16. Deputy Speaker English calls a point of order to clarify whether or not to kill the main motion
17. Senator Anastopoulos makes a motion to table the resolution indefinitely
18. Deputy Speaker English is recognized.
19. Deputy Speaker English states

- a. So if we table it indefinitely, this one is still at the first of the line and other ones can't be voted on until this one is. So, if that's what you're suggesting, I would suggest vote on this one and then voting no.

23. Clerk Corpuz calls a Point of Order for all senators to use the mics for the recording.

25. Senator Rosales states

- a. Could we rescind the motion, then make it the agenda next week?

26. Speaker Hensley states

- a. So if it's on the table for the next two weeks, she would have this week and next week to come up. At that point, that second week it would come up no matter what, would either have to table it again or not.

1. Speaker Hensley calls for a motion to discuss agenda item A. SR55010: A resolution to require the Student Trustee to give a report to the Senate twice per semester concerning the Board of Trustees.
2. Sergeant-at-Arms Bereolos so moved
3. Deputy Speaker English seconded.
4. Deputy Speaker English introduces the resolution
5. Deputy Speaker English states
 - a. Same as last week. What this requires is the student trustee to meet an equal number of times as the Board of Trustees. This way the Senate can have a better idea of what's happening at one of the highest levels of administrative access that we have over Northern Illinois University.
6. Speaker Hensley asks if there is any discussion or debate.
7. Senator Yuen is recognized.
8. Senator Yuen states
 - a. Like to ask why only twice per semester and not more than that?
9. Deputy Speaker English is recognized.
10. Deputy Speaker English states
 - a. The reason it is twice is because the Board of Trustees has historically met twice a semester, so this just lines the amount of times the student trustee is required to meet to that number. If you would, would you like it to be explicitly meet the same number of times as the Board of trustees meets first semester.
11. Senator Yuen agrees with Deputy Speaker English
12. Deputy Speaker English makes a motion to make a friendly amendment to change "Meet with the Senate twice per semester to give a report concerning the Board of Trustees" to "Meet with the Senate to give a report concerning the Board of Trustees at least once per Board of Trustees meeting."
13. Deputy Speaker English accepts the friendly amendment
14. Speaker Hensley calls for a vote.
15. This motion passes with a vote count of 10 yays, 1 nays, and 0 abstentions.

1. Speaker Hensley calls for a motion to discuss agenda item B. SR55011: A resolution to update the constitution to reflect changes made in the previous year regarding the duties of the Vice president.
2. Sergeant-at-Arms Bereolos so moved
3. Deputy Speaker English seconded.
4. Deputy Speaker English introduces the resolution
5. Speaker Hensley asks if there is any discussion or debate.

8. This motion passes with a vote count of 11 yays, 0 nays, and 0 abstentions.

2. Deputy Speaker English so moved
3. Sergeant-at-Arms Bereolos seconded.
4. Deputy Speaker English is recognized.
5. Deputy Speaker English states
 - a. As Director Innis talked about all these orgs were very courteous, they came to the meeting, they were all approved. They have my full support. I have their purposes if people want them, but all of them did pass all the things they needed to pass, except for going to this and getting full recognition.
6. Speaker Hensley asks if there is any discussion or debate.
7. Senator Rosales is recognized.
8. Senator Rosales states
 - a. For this agenda item would be running voting one all six or are we're voting six individuality for each organization?
9. Deputy Speaker English is recognized.
10. Deputy Speaker English states

- a. As it stands now we would be voting for all six. You can split the motion if you want split the question.

11. Senator Yuen makes a motion to split the motion

12. There is no second and the motion fails

13. Speaker Hensley calls for a vote.

14. This motion passes with a vote count of 10 yays, 1 nays, and 0 abstentions.

1. Speaker Hensley calls for a motion to discuss agenda item D. SR55007: A resolution to confirm Director Appointments

2. Sergeant-at-Arms Bereolos so moved

3. Senator Yuen seconded.

4. Speaker Hensley asks if there is any discussion or debate.

5. Clerk Corpuz is recognized.

6. Clerk Corpuz states

- a. I believe if we do to table this, we should at least give her at least one week, but she has also been up for this whole semester I believe as of two and a half weeks ago, and we have not heard since from her.

7. Speaker Hensley calls a Point of Information

8. Speaker Hensley states

- a. She contacted me to reschedule this from two weeks ago today. So we did hear from her once.

9. Clerk Corpuz states

- a. My point being is if we do decide to table, how long are we actually planning in talking if we do?

10. Deputy Speaker English is recognized.

11. Deputy Speaker English states

- a. Do you know if President Newman is looking at anyone else for this position?

12. Speaker Hensley states

- a. I do not think so just because she appointed Ariana.

13. Sergeant-at-Arms Bereolos is recognized.

14. Sergeant-at-Arms Bereolos states

- a. I believe we should vote on it just for the fact that she did ask for this appointment to be moved to this day and she failed to show up. I believe that it should not hinder our ability to assign a different director to this position based on the fact that she failed to show up.

15. Senator Anastopoulos is recognized.

16. Senator Anastopoulos states

- a. I can agree with that. Simply because of the fact that she had made the communication to you that she wasn't going to make it last week set for today and then just blew it off and that it just shows like a certain level of commitment as well, you know, I mean, you've been given two weeks and you want to make this thing like reunification, so despite the appointment or whatever happened. You should go on this today.

- a. I called the table this only because we don't know why she couldn't come today. I mean, that could have been an emergency on her end. So I don't think it would be fair for us to just come up with a answer today knowing that she's not here. So I do call this table for at least 2 weeks

25. Deputy Speaker English is recognized.

26. Deputy Speaker English states

- a. One thing to note with this is since this is new business, it'll almost always be before any other director appointments, so. Theoretically this one could be voted on and then other ones could be voted on. It was just if it was killed or tabled indefinitely, it wouldn't come up each meeting. So I just wanted to clarify that, but I'm in favor of tabling it for a week.
