Bylaws and Constitutions are routinely reviewed by committees and the Organization Oversight, review it, make suggestions and funding suggestions for help with clarity, responsibility, designation and accuracy intent so the changes that are being made beyond just the formatting stuff is we already do some of these steps, so the first one is officer selection proceedings. That's what we do and if you look at the next step that it's deleted. That's because some national orgs today have some of their bylaws and constitutions that are supposed to be private and second of all. As long as it follows school policy and continue pertaining to that to be recognized, or they have to, they sign it, they say they will. The national does not require that, so that's what we're suggesting that. In Section 2, we added staff because that's different designation and as it stands now, those aren't recognized. Then we clarified GPA requirements, because it should be 2.5 to 3.0 for undergraduate and graduate respectively, and we changed the way people talk to people to follow that or what we're doing. Islamophobia overall. So what that section is basically doing is saying. We think hate is not a good thing. We condemn any. Acts that perpetrate the next, therefore, is SGA will provide campus resources to the postal community, including but not limited to, mental health, educational, informal, informational resources. What that will probably look like is working with counseling and consultation services. To provide resources there as well as facilitating an educational problem, talk-in or teach-in kind of thing like the events that happen in the Holocaust The final therefore is SGA will support Palestinian, Israeli, Arab, Jewish, Muslim and allied people.
